Initial Consultations:

Routine assessments for treatment

Vision Screening Assessment with Optometrist Free of charge

- *There is a £25 charge to secure this appointment. However, this is refundable within 5 days following attendance at the appointment.*

New Patient Consultation £250

- *This fee is taken in advance of the appointment*

Follow-up Consultations within 6 months of New Patient Consultation £100

Measurements & Pre-surgical Assessment (for both eyes) £250

- *Please be advised that if you require additional scans or more in-depth assessment on the day additional fees will apply*
- *If you have private health insurance cataract assessment is usually covered, as are the detailed measurements for corneal conditions. However, insurers differ in their cover so please check with your insurer. Consultations for refractive procedures and refractive treatments are not usually covered by insurers.*

Self-Pay Procedure Fees:

These are indicative fees and include Hospital, Surgeon & where applicable Anaesthetist fees. They usually include the cost of any secondary procedures where clinically indicated. Please note these fees may change without notice and are subject to review. Please call on 01482 339515 to get pricing and detailed terms and conditions of these self-pay inclusive packages for your procedure.

Finance options available through the Spire Hospital

Information for patients with Private Medical Insurance

If you have Private medical insurance basic cataract surgery is generally covered. However advanced refractive cataract surgery including advanced intraocular lenses, femtosecond laser and any treatments to improve your vision without spectacles is generally not reimbursed. Please check with your insurer to check what level of reimbursement they will provide you for your treatment.

Responsibility for the settlement of fees

The extent of reimbursement by the private medical insurer is dependent on your insurer, level of cover and the terms of your policy. Please be advised that it is your personal responsibility to settle all accounts in full, including any excess or shortfall amounts owed.
